REGULATION UPDATED TO 17/03/2026

In 2026, during the UCI Mountain Bike World Championships, the most anticipated moment for all children returns: the CROSS-COUNTRY KIDS, an event for the whole family during which the protagonists will be your little bikers! The true champions of our future! A fun-filled race aimed at introducing little ones to the world of two wheels, making them spend a day playing on the bike! Boys and girls from 2 to 12 years old will have the opportunity to ride in Val di Sole where little champions do Greatness!

WHERE AND WHEN IT TAKES PLACE:

Inside the Val di Sole World Cup area – locality Daolasa Piazzale telecabina, 38020 Commezzadura, TN. The race will be held on **Friday, August 28, 2026**, the meeting place is at 5:30 PM c/o Cross-Country Arch.

ENROLLMENTS:

Registration via the online form on the official page is compulsory: by **Friday, August 21**, until midnight, registration is free for all!
On-site registrations are not possible.

WITHDRAW NUMBER:

The number will be collected at the accreditation room of the Municipality of Commezzadura on Via del Comun in Mestriago. On **Friday, August 28**, from 3:00 PM to 5:00 PM. It will not be possible to collect the numbers days in advance or at times other than those indicated.

ENTRY TO THE COMPETITIONS AREA FOR ATHLETES AND COMPANIONS:

ROUTE:

Loop XCO course of different length depending on category, for the foxgirl there is a short course. The course is identified on semi-flat stretches of grassland to be repeated several times always according to the category.

CATEGORY:

- 2-4 Years- *born in 2022 - 2024*: **Cheeks** (parents can accompany children)
- 5-6 Years- *born in 2020-2021*: **Foxgirl** (parents can accompany children)
- 7-8 Years- *born in 2018-2019*: **Pheasants**
- 9-10 Years- *born in 2016-2017*: **Roe deers**
- 11-12 Years- *born in 2014-2015*: **Deers**

PROGRAM:

Meet at 5:30 p.m c/o Arco di Cross-country.

At about 6:00 p.m the youngest children will start first, followed by the other categories. An awards ceremony will follow.

COMPULSORY EQUIPMENT AND PROTECTION:

Approved helmet, bike without footpegs and in good repair are compulsory. Handlebar appendages and footpegs mounted on children's bikes are prohibited. You can also participate with bikes without pedals (pushbike, balance bike).

AWARDS:

All the little champions will be awarded on the World Cup stage at the end of the race. A prize is provided for all registered children.

TIMING:

The Mini world cup does not involve ranking and timing, it is a time for no-competitive children to get together and celebrate.

MEDICAL CERTIFICATE:

To be eligible to participate in the Mini World Cup, each participant must have a Medical Certificate of Good Health (NON-Competitive), and have it properly uploaded in the online form during booking
